# ThinkSystem Bundle Bonus Cashback Incentive

- For a limited time and under limited availability on a “first come, first served” basis, the “ThinkSystem Bundle Bonus Incentive” provides eligible Lenovo resellers a chance to earn cashback for selling Lenovo ThinkSystem servers with an Intel® Xeon® Silver processor, and the Lenovo Foundation Service (2 years extended service agreement). Resellers have an additional chance to win more cashback when attaching a Windows Server 2016 Essentials or Standard Edition ROK from Lenovo.

# ThinkSystem Bundle Bonus Incentive Program – Eligible Resellers

- **Eligible Resellers:**

To be eligible to participate in this program, resellers must:

- Be located in the **Europe, Middle East Africa (EMEA) region and have qualifying sales between October 1<sup>st</sup> and 31<sup>st</sup> December 2018.**

  - Be registered on LenovoPartner.com and have signed the Lenovo Partner Network Agreement and Special Bid Addendum.
  - Resellers must purchase Lenovo ThinkSystem servers with an Intel® Xeon® Silver processor, with the Lenovo Foundation Service (2 years extended service agreement) from a Lenovo distributor. Additional cashback can be earned by a reseller when attaching a Windows Server 2016 Essentials or Standard Edition ROK from Lenovo.
  - Submit a valid claims form at [www.LenovoBundleBonus.com](http://www.LenovoBundleBonus.com) on or before 14<sup>th</sup> January 2019 23:59 GMT.
  - Provide a copy of a **valid distributor invoice** for eligible products in support of each claim.
  - Confirm on the claims form that all of the information provided is accurate, complete, and in accordance with these terms and conditions.
- Eligible resellers may aggregate and submit all eligible claims at one time on or before 14<sup>th</sup> January 2019 OR submit each individual claim throughout the program period via the website using a distributor invoice.

# ThinkSystem Bundle Bonus Cashback Incentive

- Each reseller is eligible to claim up to a maximum of 10 designated combinations. The total cashback is capped at \$2800/£2100/€2300 per reseller.
- Cashback will be paid by bank transfer. Bank transfers will only be paid to eligible reseller business entities and not to any individual or other named commercial entity. It is the responsibility of the eligible reseller to distribute the cashback to any relevant employee internally. Lenovo accepts no responsibility or liability for the distribution of cashback within any eligible reseller. Bank transfers will only be made by “Agency” upon receipt of full and valid bank details. Failure to provide full and correct bank details may result in the cashback payment being delayed or not paid. The eligible resellers will be contacted to arrange payment via the email address [contact@LenovoBundleBonus.com](mailto:contact@LenovoBundleBonus.com)
- All cashback will be paid out after the end of the quarter in January, after all claims have been validated by Lenovo. Eligible resellers will be contacted after this date to confirm the validity of their claims.

# How to claim

- Eligible resellers must connect to [www.LenovoBundleBonus.com](http://www.LenovoBundleBonus.com) and complete all required fields in the claim form **no later than January 14<sup>th</sup> 2019 23:59 GMT** and provide a valid copy of their distributor invoice(s) listing the eligible products and eligible servers with prices redacted.

Invoices must include the invoice date and be itemised to show part numbers and serial numbers for the Lenovo ThinkSystem servers with an Intel® Xeon® Silver processor and the Lenovo Foundation Service (2 years extended service agreement). If the reseller has chosen to attach Windows Server 2016 Essentials or Standard Edition ROKs from Lenovo this must also be shown on the invoice.
- Handwritten or altered documents will not be accepted.
- The company name appearing on the claims form must match the information provided on the invoices/lease documentation.
